However, as a courtesy, the LA County Lifeguards do make available a limited supply of soft paddleboards, the morning of the race at the Manhattan Pier start, to be borrowed on a **FIRST COME FIRST SERVE BASIS**.

Awards: In each division, awards will be for 1st, 2nd and 3rd places.

Competition: Check-in will begin at 6:30 a.m. at the Lifeguard Tower north of the Manhattan Beach Pier. Paddlers will start off the end of the Manhattan pier (water start) at 7:30 a.m. sharp. The course will proceed south to the Hermosa Pier where paddlers **ROUND** the end of the Hermosa Pier and proceed to **Paddle to the beach**. Paddlers then run up the beach to the finish line. The finish line, **ON THE BEACH** south of the Hermosa Pier will be clearly marked by a bright colored arch.

Entries must be received by July 31, 2010 or a late charge will be assessed. Entries will be accepted on race day at \$30.00. Any racer not finished by 8:45 a.m. may be disqualified and required to leave the course.
